TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales gives notice that on the application of South Glamorgan County Council he has made an Order under Section 212 of the Town and Country Planning Act 1971 for extinguishing any rights which persons may have to use vehicles on those lengths of road described in Schedules 1A, 2A and 3 to this Notice.

- The Order contains provisions for permitting:

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirements of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within six weeks of 20th October 1975, apply to the High Court for the suspension or quashing of the Order or of any provision contained

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway to which the Order relates may claim compensation from the South Glamorgan County Council in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or deprecy which is contributable. loss or damage which is so attributable.
