PRIVY COUNCIL OFFICE

At the Court at Balmoral, the 17th day of September 1975

PRESENT

The QUEEN'S Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (c. 73) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

### Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Pay and Allowances) Order 1975.

### Interpretation

2. The Interpretation Act 1889 (c. 63) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

### General

3. The revised rates of pay and allowances set out in the Schedules to this Order shall have effect from 1st April 1974 except as may be specified otherwise in the said Schedules and shall be payable, subject to the regulations made by the Defence Council or the Admiralty Board on their behalf, in respect of Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines and of members of the Naval and Marine Reserves while serving or training in Her Majesty's Ships or Establishments; the said rates and allowances shall not apply to Officers appointed for time only or otherwise holding Naval rank for purposes of status only or to personnel recruited abroad for local service. The rates in the Schedules shall be read as daily rates, unless otherwise specified.
4. Education Grants may be awarded in accordance with Schedule 1 to this Order.
5. Officers, Ratings and Other Ranks of the Royal Naval Reserves and Royal Marines Reserves shall receive the rates of pay shown in Schedules 4 and 5 to this Order, except that the rates shown in Schedules 2 and 3 to this Order shall apply as directed by the Admiralty Board when such personnel fill complemented Active List appointments.
6. Increments of pay for Officers of the Royal Naval Reserve and the Royal Marine Reserve shall depend on mobilised service at naval rates of pay in the confirmed or paid acting rank, or as may be provided by the Defence Council or the Admiralty Board on their behalf.
7. Lieutenants of the Careers Service shall be paid according to years in the rank at the rates shown in sub-paragraph 6 of Schedule 2 to this Order.
8. Revised rates of allowances and additional pay shall be payable in accordance with Schedule 6 to this Order.
