The Trunk Road (Chepstow, Gwent) (Prohibition of Waiting) Order 1975

Notice is hereby given that the Secretary of State intends to make an Order under Section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting:

1. at any time on any day on that length of highway in Schedule 1; and
2. between the hours of 8 a.m. and 6 p.m. on any day on that length of highway specified in Schedule 2.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties.

Exceptions will also be provided in the Order to allow vehicles bearing both a disabled person's badge and a park-

ing disc to wait in the length of road or on any of the sides of road specified in the Schedules to this notice for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road or on the same side of road).

Notice is hereby given that the Southern Water Authority of Guildbourne House, Chatsworth Road, Worthing, Sussex propose to abstract the following quantities of water from the River Stour at a place adjacent to Stonar Lake, near Sandwich, Kent, National Grid Reference TR 337 589: (a) 130,000,000 gallons in total; (b) 2,320,000 gallons in any one day of 24 hours; (c) 290,000 gallons in any one hour. The water is to be used to replace water abstracted from Stonar Lake and discharged to the River Stour in the course of hydrogeological investigations and will be abstracted in full within a period of 100 days. The proposals set out in the form of a draft licence together with a plan may be inspected by the public free of charge at all reasonable hours during the period beginning on 7th November 1975 and ending on 5th December 1975 inclusive at the Authority's offices at East Kent Water and Drainage Division, Westwood Road, Broadstairs, Kent.

Any person wishing to make representations about the proposals should do so in writing to the Chief Solicitor, Southern Water Authority, Guildbourne House, Chatsworth Road, Worthing, Sussex BN11 1LD before the end of the said period.

NEWCASTLE UPON TYNE CITY COUNCIL

The City of Newcastle upon Tyne (Back Heaton Park Road (West)/Stratford Road and Warwick Street) Prohibition of Driving Order 1975
