The Trunk Road (Chepstow, Gwent) (Prohibition of Waiting) Order 1975

Notice is hereby given that the Secretary of State intends to make an Order under Section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting:

- 1. at any time on any day on that length of highway in Schedule 1; and
- between the hours of 8 a.m. and 6 p.m. on any day on that length of highway specified in Schedule 2.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties.

Exceptions will also be provided in the Order to allow vehicles bearing both a disabled person's badge and a park-

ing disc to wait in the length of road or on any of the sides of road specified in the Schedules to this notice for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road or on the same side of road).
