The Greater Manchester County (Roscoe Road, Irlam) (Prohibition of Waiting) (City) Order, 1975

Notice is hereby given that the Salford City Council, acting on behalf of the Greater Manchester County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1967 (as amended).

When this Order comes into effect you will not be allowed to cause or permit any vehicle (unless that vehicle is a disabled person's vehicle displaying the relevant disabled person's badge and parking disc and then only for a maximum period of two hours, return prohibited within one hour), to wait at any time on both sides of Roscoe Road, Irlam, from a point 14 metres north-west of its junction with Liverpool Road to a point 50 metres north-west of its junction with Liverpool Road.

Exceptions will permit waiting for so long as may be necessary on the said length of road for the purposes of boarding or alighting, loading or unloading, the removal of furniture, funerals, building operations or work on or under the length of road.
