

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 11th November 1975, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway to which the Order relates may claim compensation from the Torfaen Borough Council in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.

Description of the highway on which vehicular rights are to be extinguished

The highway is at Cwmbran, in the Borough of Torfaen, in the County of Gwent, and is that length of road known as Pen-y-Parc which extends from a point 150 yards south of its junction with Five Locks Road in a southerly direction for a distance of 21 yards.
