

which persons may have to use vehicles on those lengths of highway specified in the Schedule to this notice.

The Order contains provisions for permitting the use of those highways by vehicles being used:

- (a) in pursuance of statutory powers or duties if that vehicle cannot be conveniently be used for such purpose in any other road; or
- (b) in accordance with the special authorisation for that use given by or on behalf of the Brecknock Borough Council, or the Chief Officer of Police for the Dyfed Powys Constabulary.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Roads Department (Y Swyddfa Gymreig, Adran Ffyrdd), Graham Buildings, 139 Newport Road, Cardiff, CF2 1YU (quoting the reference WR 15/6/6), and may be inspected at the offices of the Brecknock Borough Council, Oxford House, The Watton, Brecon.

Any person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 31st December 1975, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person, who at the time of the coming into operation of the Order, has an interest in land having lawful access to the highway to which the Order relates may claim compensation from the Brecknock Borough Council in respect of any depreciation in the value of the interest which is directly attributable to the Order and of any other loss or damage which is so attributable.

SCHEDULE

Description of highways to which this Order relates (the distances stated are approximate). The highways are situated at Llanfaes, in the Borough of Brecknock, in the County of Powys and are:

1. That length of road, known as St. David Street which extends from its junction with Orchard Street to its junction with Newmarch Street, a distance of 101 yards; and
2. That length of road, known as Newmarch Street which extends from a point 50 yards north-east of its junction with St. David Street to a point 45 yards south-west of that junction, a distance of 95 yards.
