TYNE & WEAR COUNTY COUNCIL

Tyne and Wear County Council (Haymarket/Percy Street Junction, Newcastle upon Tyne) (Box Junction) Order 1975

The Greater Manchester County (Domett Street, Lawson Street and Quilter Grove, Manchester) (Restriction of Waiting) (City) Order 1975

Notice is hereby given that the Manchester City Council as agents for the Greater Manchester County Council propose to make Orders under Section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

Topaz Street	The east side from its junction with Sarah Ann Street for 20 metres in a northerly direction.
Topaz Street	The east side from a point 95 metres north of its junction with Sarah Ann Street for 35 metres in a northerly direction.
Sarah Ann Street	The south side from its junction with Forge Lane to a point 70 metres east of its junction with Rowsley Street.
Sarah Ann Street	The south side from its junction with Rowsley Street for 20 metres in an easterly direction.
Sarah Ann Street	The north side from its junction with Rowsley Street to a point 10 metres east of its junction with Topaz Street.
Sarah Ann Street	The north side from a point 110 metres east of its junction with Topaz Street for 35 metres in an easterly direction.
Sarah Ann Street	The north side from its junction with Forge Lane for a distance of 40 metres in a westerly direction.

(b) to restrict waiting by vehicles to 2 hours in any 3 hours between 8 a.m. and 6 p.m. on Monday to Fridays and 8 a.m. and 12.30 p.m. on Saturdays on the following lengths of roads:

Topaz Street	The east side from a point 20 metres north of its junction with Sarah Ann Street for 75 metres in a northerly direction.
Glass Street	The north side from a point 25 metres east of its junction with Parcel Street for 25 metres in an easterly direction.
Sarah Ann Street	The south side from a point 20 metres east of its junction with Rowsley Street for 50 metres in an easterly direction.

Sarah Ann Street The north side from a point 10 metres east of its junction with Topaz Street for 100 metres in an easterly direction.

Sarah Ann Street The north side from a point 40 metres west of its junction with Forge Lane for 35 metres in a westerly direction.

(c) to prohibit waiting by vehicles at any time on both sides of King's Lynn Close, Didsbury.

Lawson Street, Blackley The south side from a point 19 metres (62 feet) west of the junction with Domett Street, westwards, for a distance of 78 metres (258 feet).

Quilter Grove, Blackley The north side.

The proposed Orders contain exceptions to permit waiting for the purposes of boarding or alighting, loading or unloading, the removal of furniture, funerals, building operations or work on or under any of the lengths of road or to take in petrol, oil, water or air from any garage on or adjacent to any of the lengths of road but the loading or unloading of vehicles will be prohibited in the roads listed in paragraph (a). Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait for up to two hours, return prohibited within one hour in the roads listed in paragraphs (c) and (d).

- (b) to prohibit all motor vehicles except for Public Service Vehicles and construction vehicles requiring access to Blackett Street, from entering into Blackett Street from the west at its junction with Percy Street;
- (c) to prohibit all motor vehicles (other than Public Service Vehicles) travelling in either direction in Blackett Street to proceed beyond a point 10 metres west of the eastern leg of Eldon Square.

3. Nothing in Article 2 shall apply to any police, fire or ambulance vehicles or statutory undertakers vehicles on emergency call, or to local authority vehicles requiring access for the purpose of the performance of statutory duties.

4. When the Order comes into effect the provisions of Item 6, Schedule 25 to the City and County of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 1975 will be revoked.

5. When the Order comes into effect the provision of Article 3 of and paragraph (b) of the First Schedule to the Tyne and Wear County Council (Monument, Newcastle upon Tyne) Temporary Traffic Regulation (No. 1) Order 1974 insofar as they relate to Blackett Street, Newcastle upon Tyne will be revoked.

The Borough of Sunderland (The Retreat) (Prohibition of Waiting) Order 1975
