*The London—Holyhead Trunk Road (Diversion East of Froncysyllte) Order 197*

and

*The London—Holyhead Trunk Road (Diversion East of Froncysyllte Side Roads) Order 197*

The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

1. an Order under section 7 of the Highways Act 1959 providing that a road which he proposes to construct at Froncysyllte in the County of Clwyd shall become a trunk road as from the date when the Order comes into operation;
2. an Order under section 9 of the Highways Act 1959 authorising him—
  - (a) to stop up part of the existing London—Holyhead trunk road;
  - (b) to stop up private means of access to premises; and
  - (c) to provide new means of access to premises,

all in the vicinity of the disused Lime Kilns to the east of Froncysyllte aforesaid.
