NOTICE OF APPLICATION FOR LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the South West Water Authority by the Dartmoor National Park Department, County Hall, Exeter, for a licence to abstract the following quantities of water from the pond at SX 735 791 (Swallerton Gate—Hound Tor) at the following point of abstraction:

1,000 gallons per day at SX 735 791.

Further details of the application are: Extraction of water is to serve proposed public lavatories situate at SX 739.4 792.2 (Swallerton Gate Car Park).

NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Welsh National Water Development Authority proposes to vary Licence No. 24/67/4/10/S which authorises the Authority to abstract water from the Afon Ceirw at Maerdy Mill, near Corwen at N.G.R. SJ 017 445 for fish hatchery purposes.

The variation proposed is to increase the quantities authorised to be abstracted from 146,400,000 gallons per year, 400,000 gallons per day to 549,000,000 gallons per year, 1,500,000 gallons per day or 50 per centum of the flow in the Afon Ceirw, whichever is the less, for the purpose of supplying trout rearing ponds. All water abstracted will be returned to the river at various points downstream, the furthest such point of return being 485 metres downstream of the abstraction point.

A copy of the proposed draft licence variation together with any maps deposited with it will be open to inspection by the public at the offices of the Dee and Clwyd River Division at 2 Vicar's Lane, Chester, and at Bryn-yr-Aber, Bala, Gwynedd, free of charge, during normal office hours during the period beginning 28th November 1975 and ending on 28th December 1975.

Any person who wishes to make representations about the above proposals should do so in writing to the Divisional Manager, Dee and Clwyd River Division at 2 Vicar's Lane, Chester, before the end of the said period.

After the expiry of the above-mentioned period the Authority will be entitled to pass a resolution by virtue of which a licence authorising the proposals shall be deemed to be granted, unless the Secretary of State for the Environment and the Secretary of State for Wales, either in consequence of any representations made with respect to the proposals or otherwise, require an application for a licence to be made to them.

NOTICE OF APPLICATION FOR LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS.

Notice is hereby given that an application is being made to the Anglian Water Authority, Great Ouse River Division by Brian Keith Hargreaves and Norman Clifford Hargreaves for a Licence to obstruct or impede the flow of water in Beachampton Brook which flows through Potash Farm, Beachampton, Milton Keynes, Buckinghamshire by means of impounding works whereby a compensation weir is constructed at Ordnance Survey Grid Reference SP779 359 in the Parish of Beachampton in the District of Aylesbury Vale.

The object of impounding water by means of the works is in order to stop Beachampton Brook from drying up.

The Gas (Declaration of Calorific Value) Regulations 1972

Notice is hereby given in pursuance of the Act and Regulations above referred to, that on and after the 1st day of January 1976, the British Gas Corporation will supply gas of the new calorific value of 1027 British Thermal Units per cubic foot to consumers in the area comprising the local
