### WESSEX WATER AUTHORITY WATER ACT 1958

#### NOTICE OF APPLICATION FOR DROUGHT ORDER

Notice is hereby given that because of exceptional shortage of rain in the Somerset Division, Wessex Water Authority is applying to the Secretary of State for the Environment

for an Order under section 1 of the Water Act 1958. The effect of the Order would be:

1. To authorise the Authority for a period of six months from the making of the Order:

(a) to reduce from not less than 250,000 gallons per day to not less than 50,000 gallons per day, the flow of water which the Authority is required by section 12 (1) of the Taunton Corporation Act 1940, to maintain in the River Otter;

(b) to reduce from not less than 250,000 gallons per day to not less than 50,000 gallons per day, the flow of water which the Authority is required by section 13 of the Taunton Corporation Act 1940, to maintain in the River Otter at the gauge at or near National Grid Reference ST226131 at Royston Water in the Parishes of Churchstanton and Otterford in the District of Taunton Deane in the County of Somerset;

(c) to reduce from not less than 750,000 gallons per day to not less than 550,000 gallons per day (in summer months) and from not less than 1,000,000 gallons per day to not less than 800,000 gallons per day (at other times) the flow of water which the Authority is required to maintain in the River Otter at the gauge at or near National Grid Reference ST 221120 at Knacker's Hole in the Parishes of Churchstanton and Otterford in the District of Taunton Deane in the County of Somerset.

2. To make appropriate modification to Licence Serial No. 14/45/01/0002/09/60 granted on the 10th December 1965 to the former West Somerset Water Board under the Water Resources Act 1963.

A copy of the relevant map on which the above references are noted may be inspected free of charge at the Head Office of the Authority, Techno House, Redcliffe Way, Bristol, BS1 6NY or its Divisional Office, 150 Priorswood Road, Taunton, Somerset, during the period of seven days from the date of publication of this notice.
