The Trunk Road (Llanrhystyd, Dyfed) (Restricted Roads and 40 m.p.h. Speed Limit) Order 197

Notice is hereby given that the Secretary of State for Wales intends to make an Order under sections 72, 73, 74 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be:

- (a) to revoke The Trunk Roads (Restricted Roads) (No. 16) Order 1964 and The Trunk Roads (Restricted Roads) (Wales) (No. 1) Order 1968 which together imposed a 30 miles per hour speed limit on the length of road specified in Schedule 1 to this Notice;
- (b) to impose a 40 miles per hour speed limit on the length of road specified in Schedule 2 to this Notice; and
- (c) to impose a 30 miles per hour speed limit on the length of road specified in Schedule 3 to this Notice.

A copy of the proposed Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at the offices of the Ceredigion District Council, Town Hall, Aberystwyth.
