Public Path Diversion Order 1975*

Notice is hereby given, that the above-named Order, made on 25th November 1975, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the Wiltshire County Council.

The effect of the Order, if confirmed without modifications, will be to divert a length of the public right of way known as Footpath 123 in the Parish of Purton as described below:

That length of Footpath No. 123 which runs from its junction with the road No. C.76 at a point at the north-eastern corner of O.S. Plot No. 63 in a general south-westerly direction to a point mid-way along the boundary between O.S. Plots Nos. 63 and 65 shall be diverted to run in a westerly direction from a point mid-way along the boundary between O.S. Plot No. 63 and the C.76 road to the point on the boundary between O.S. Plots Nos. 63 and 65 aforesaid, so as to provide a more commodious route.

A copy of the Order and plan contained in it has been deposited at the County Solicitor and Clerk's Office (Environment Division), County Hall, Trowbridge and at the offices of the Director of Administrative Services, North Wiltshire District Council, Monkton Park, Chippenham and at the Area Office of the North Wiltshire District Council, Manor House, Wootton Bassett, and may be inspected during normal office hours.

Grassington Diversion Order 1975*

Notice is hereby given that the above-named Order made on 27th November 1975 is about to be submitted to the Secretary of State for the Department of the Environment for confirmation as an opposed Order, or to be confirmed as an unopposed Order, by North Yorkshire County Council.

The effect of the Order if confirmed without modification will be to divert the public right of way commencing from point A (marked on the map) which is located at the furthest point west of the pavement in Raines Meadows, Grassington, and running south-westwards for a distance of approximately 200 feet to meet a set of steps in Raines Lane at point B the new path commencing at point A and running south-westwards for a distance of approximately 170 feet partly through field O.S. 257 then due south for approximately 20 feet turning south-westwards to emerge onto Raines Lane, at point C down a new set of steps approximately 12 feet north of the existing steps.
