## SCHEDULE

To prohibit the waiting of any vehicle between 8 a.m. and 6 p.m. on:

1. *Holly Street.*

2. *Kendrew Street*

The east and north sides from a point 4 yards north of the south-west corner of the Public Baths to the eastern end of the street.

The west and south sides from the northern side of the car park entrance southwards and eastwards to the end of the street.

Exceptions have been made in the Order for vehicles to wait for so long as may be necessary:

1. To enable a person to board or alight from the vehicle.

2. To enable goods to be loaded on to or unloaded from the vehicle.

3. To enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road, or the sides of roads so referred to or the laying, erection, alteration or repair in or near the said road, the said sides of roads of any sewer or of any main, piper or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878.

4. To enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or water authority in pursuance of statutory powers or duties.

5. To enable a disabled persons vehicle displaying a disabled persons badge and a parking disc marked with the time at which the period began in accordance with the provisions of the Order to wait for not more than 2 hours return prohibited within 1 hour. (789)
