(*Box Junction*) Order 1975

Notice is hereby given that Tyne and Wear County Council propose to make an Order under Section 1 (1), (2), (3) and (3B) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

(*Prohibition of Commercial Vehicles and Contract Carriages*)  
*of Over 3 Tons (Nos. 5, 6 and 7) Orders 1975*

Notice is hereby given that on the 8th December 1975 the Newport Borough Council made three Orders acting on behalf of the Gwent County Council in pursuance of arrangements made under Section 101 of the Local Government Act 1972 and in exercise of the Gwent County Council's powers under Section 1 (1), (2), (3) and (3AA) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972, Schedule 6 to the Road Traffic Act 1974 and Section 1 of the Heavy Commercial Vehicles Controls and Regulations Act 1973.

2. The Orders will come into operation on the 12th January 1976.

3. The effect of the Orders is to prohibit Heavy Commercial Vehicles and Contract Carriages, the unladen weight of which exceeds 3 tons, from proceeding or waiting between the hours of 11 p.m. on any day and 7 a.m. on the day next following in the roads or the unnamed access roads listed alongside each Order, viz:

(a) *The Newport Borough Council (Various Roads) (Prohibition of Commercial Vehicles and Contract Carriages of over 3 Tons) (No. 5) Order 1975*

(i) the following roads: Badminton Road, Beaufort Place, Beaufort Road, Brangwyn Crescent, Burton Road, Carlton Road, Constable Drive, Cotman Close, Denbigh Road, Elaine Crescent, Firbank Avenue, Firbank Crescent, Flint Close, Gainsborough Drive, Goya Close, Heather Road, Hogarth Close, Holbein Road, Hove Avenue, Hubert Road, Kelly Road, Landseer Close, Lavery Close—formerly known as Raeburn Close, Merlin Crescent, Monet Crescent, Munnings Drive, Piper Close, Raphael Close, Rembrandt Way, Renoir Road, Reynolds Close, Romney Close, Rubens Close, St. Julians Avenue, Sickert Close, Steer Crescent, Sutherland Crescent, Tudor Road, Vale View, Van Dyke Close, Vermeer Crescent, Ward Close, Whistler Close, Wilson Road, Worcester Crescent;

(ii) the unnamed access roads leading from the following roads: Beaufort Road, Brangwyn Crescent, Constable Drive, Firbank Avenue, Heather Road, Kelly Road, Merlin Crescent, Rembrandt Way, Renoir Road.

(b) *The Newport Borough Council (Various Roads) (Prohibition of Commercial Vehicles and Contract Carriages of Over 3 Tons) (No. 6) Order 1975*

(i) the following roads: Bacon Place, Baird Close, Bessemer Close, Blackett Avenue, Boyle Close, Cartwright Green, Chadwick Close, Curie Close, Darwin Drive, Davy Close, Edison Ridge, Faraday Close, Fleming Close, Graham Bell Close, Haldane Place, Hargreaves Drive, Harvey Close, Huxley Green, Jeans Close, Kelvin Close, Lister Green, Marconi Close, Newton Way, Oliphant Circle, Penny Crescent, Rankine Close, Russell Drive, Rutherford Hill, Simpson Close, Trevithick Close, Watt Close, Whittle Drive;

(ii) the unnamed access roads leading from the following roads: Blackett Avenue, Darwin Drive, Oliphant Circle, Russell Drive.

(c) *The Newport Borough Council (Various Roads) (Prohibition of Commercial Vehicles and Contract Carriages of Over 3 Tons) (No. 7) Order 1975*

(i) the following roads: Blaen-y-pant Avenue, Blaen-y-pant Crescent, Blaen-y-pant Place, Coolgreany Close, Coolgreany Crescent, Craig Park Avenue, Craig Park Circle, Craig Park Hill, Craig Park Lane, Craig Park Parade, Craig Park Road, Craig Park Villas, Craig Wood Close, Hollybush Avenue, Hollybush Close, Llanover Close, Moxon Road, Westfield Avenue, Westfield Drive, Westfield Way.

(ii) the unnamed access roads leading from the following roads: Blaen-y-pant Crescent and Moxon Road.

4. Exceptions will be included in the Orders to permit such heavy commercial vehicles and contract carriages to proceed or wait on any of the lengths of roads referred to in paragraph 3 (a), (b) and (c) for the purposes of:

(i) building, industrial or demolition operations; (ii) removal of obstruction to traffic; (iii) the maintenance, improvement or reconstruction of the roads; (iv) the laying, erection or alteration or repair in, or in land adjacent to, the roads of any sewer or any main, pipe or apparatus for the supply of water, gas or electricity or any telegraphic line as defined in the Telegraph Act 1878.

(a) fire brigade, police or ambulance services; (b) the service of a Local Authority or Water Authority in pursuance of statutory powers or duties; (c) conveyance of persons to or from any premises situated on or adjacent to those lengths of roads and to wait for as long as may be necessary to enable a person to board or alight from the vehicle.

5. Existing Orders imposing restrictions on vehicles over 2½ tons unladen weight have been revoked.

6. The Orders and maps showing the affected lengths of roads may be inspected at my office between 8.30 a.m. and 4.30 p.m. Mondays to Fridays.

7. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 8th December 1975 apply to the High Court for this purpose.—Dated 15th December 1975.

- to revoke Article 2 of the City Council of Liverpool (Vernon Street/Bachelor Street) (One-Way Traffic, Prohibition of Driving and Prohibition of Waiting) Order 1973;
- to prohibit any vehicle to proceed in the roads or length of road specified in column 1 of Schedule 1 to this Order in a direction other than that specified in column 2 of the said Schedule;
- to cause any vehicle, proceeding in Hockenhall Alley, on reaching the junction of Hockenhall Alley with Dale Street to make a right hand turn into Dale Street;
- to cause any vehicle, proceeding in Cumberland Street, on reaching the junction of Cumberland Street with Dale Street, to make a left hand turn into Dale Street.

2. *(Blackmoor Drive) (Prohibition of Driving and Prohibition of Waiting) Order*

- to prohibit any vehicle, proceeding in a south-westerly direction along Honeys Green Lane, to make a right hand turn into Blackmoor Drive;
- to prohibit any vehicle, proceeding in a north-westerly direction along Blackmoor Drive, south-east of its junction with Honeys Green Lane, to enter Blackmoor Drive, north-west of Honeys Green Lane;
- to prohibit with certain exceptions, the waiting by vehicles at any time in the length of road or sides of lengths of road specified in Schedule 2 to this notice.

3. *(Utting Avenue) (Prohibition of Waiting) Order*

to prohibit with certain exceptions, the waiting by vehicles at any time in the lengths of roads and side of lengths of road specified in Schedule 3 to this notice.

4. *(Hanson Road) (Prohibition of Waiting) Order*

to prohibit with certain exceptions, the waiting by vehicles at any time on the south-east side of Hanson Road, from a point 110 metres from its junction with Long Lane for a distance of 79 metres in a north-easterly direction.

5. *(Adelaide Place) (Prohibition of Waiting) Order*

to prohibit with certain exceptions, the waiting by vehicles at any time in Adelaide Place.

The exceptions referred to will enable a vehicle to wait for so long as is necessary: (a) to enable a person to board or alight from the vehicle; (b) to enable the vehicle to be used in connection with any wedding, funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; (c) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said side of lengths of roads or lengths of roads; (d) to enable goods to be loaded on to or unloaded from the vehicle.
