## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### RUBBER PROOFED GARMENT MAKING INDUSTRY WAGES COUNCIL

The Rubber Proofed Garment Making Industry Wages Council hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in Schedule 1 to the Wages Regulation (Rubber Proofed Garment) Order 1975 (Order R.P.G. (42)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Rubber Proofed Garment) (Holidays) Order 1974 (Order R.P.G. (39)) as amended by Schedule 2 to the Wages Regulation (Rubber Proofed Garment) Order 1975 (Order R.P.G. (42)); and (3) the revocation of Order R.P.G. (42).

Particulars of the proposals are contained in the Wages Council's Notice R.P.G. (43) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 16th December 1975. Any such representation should bear the writer's address and signature and be sent to the Secretary, Rubber Proofed Garment Making Industry Wages Council, 12 St. James's Square, London, SW1Y 4LL. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals R.P.G. (43).

## DEPARTMENT OF THE ENVIRONMENT

### ROAD TRAFFIC REGULATION ACT, 1967

For the purpose of section 13 (5) and of all other relevant provisions of the above Act, the Secretary of State for the Environment hereby gives notice in accordance with the Special Roads (Notice of Opening) Regulations 1962 that the 23rd December 1975, will be the date on which all the special roads and lengths of special roads described in the Schedule hereto are open for use as special roads.

#### THE SCHEDULE

1. *The M.62 (East of Queens Drive, Liverpool to Tarbock Section) Motorway and Connecting Roads Scheme 1970 (S.I. 1970/1247).*

(a) The eastbound carriageway of the special road provided in pursuance of this Scheme which extends from a point in the Metropolitan District of Liverpool about 417 yards south-east of the centre of the roundabout at the junction of Queens Drive and Bowring Park Road and proceeds in a generally south-easterly direction for about 3.5 miles to a point in the Parish of Tarbock near Huyton about 547 yards south-west of the centre of the junction of Cronton Road and Ox Lane (this being the starting point of the special road provided in pursuance of the M.62 Lancashire-Yorkshire Motorway (Tarbock to Croft Section) Scheme 1968);

(b) Two of the special roads provided in pursuance of this Scheme and referred to in article 1(b) of this Scheme. These are routes to connect:

(i) The east bound carriageway of the M.62 with the roundabout on Tarbock Road (A.5080) at Bowring Park (Numbered 5 on the deposited plan of the Scheme);

(ii) The roundabout at Tarbock Road (A.5080) at Bowring Park to the eastbound carriageway of the M.62 (Numbered 2 on the deposited plan of the Scheme).

2. *The M.62 Lancashire-Yorkshire Motorway (Tarbock to Croft Section) Scheme 1968 (S.I. 1968/948).*

0.71 miles of the eastbound carriageway of the special road provided in pursuance of this Scheme from a point about 547 yards south-west of the centre of the junction of Cronton Road and Ox Lane in the Parish of Tarbock near Huyton and proceeding in a generally easterly direction
