

SCHEDULE 1

(No Waiting at any time)

1. *Portfield*, the south side, from its junction with Portfield Avenue in both easterly and westerly directions for distances of 15 yards.
2. *Portfield*, the north side, from its junction with Cromie Avenue in both easterly and westerly directions for distances of 15 yards and from a point 40 yards east of its junction with Cromie Avenue in an easterly direction for a distance of 41 yards.
3. *Portfield*, from its junction with Jury Lane in a westerly direction for a distance of 15 yards.

SCHEDULE 2

(No waiting 8 a.m. to 6 p.m.)

1. *Portfield*, the south side from a point 15 yards west of its junction with Jury Lane in a westerly direction to a point 15 yards east of its junction with Portfield Avenue and from a point 15 yards west of its junction with Portfield Avenue in a westerly direction to a point 94 yards east of its junction with Snowdrop Lane.

SCHEDULE 3

(Limited Waiting of 1 hour between 8 a.m. and 6 p.m.)

1. *Portfield*
 - (a) the north side from a point 15 yards west of its junction with Jury Lane in a westerly direction to a point 81 yards east of its junction with Cromie Avenue and from a point 40 yards east of its junction with Cromie Avenue in a westerly direction for a distance of 25 yards.
 - (b) the north side from a point 15 yards west of its junction with Cromie Avenue in a westerly direction to a point 94 yards east of its junction with Snowdrop Lane.

DYFED COUNTY COUNCIL

The County of Dyfed (Various Roads, Pembroke)
(Prohibition and Restriction of Waiting) Order, 197

Notice is hereby given that the Dyfed County Council propose to make an Order under section 1 (1), (2) and (3) and section 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and Schedule 19 to the Local Government Act 1972.

The effect of the Order will be to:

- (a) Prohibit waiting at any time in the lengths of road specified in Schedule I to this notice;
- (b) Prohibit waiting between the hours of 8 a.m. and 6 p.m. on the side of road specified in Schedule II to this notice;
- (c) Prohibit waiting between the hours of 8 a.m. and 6 p.m. on the side of road specified in Schedule III of this notice, during the period commencing 1st April and ending 30th September in each year;
- (d) Restrict waiting for 1 hour in any period of two hours between the hours of 8 a.m. and 6 p.m. on those sides of road and in those lengths of road specified in Schedule IV of this notice.

The Order will contain the usual exemptions to:

- (a) enable a person to board or alight from the vehicle;
- (b) enable goods to be loaded on to or unloaded from the vehicle;
- (c) enable the carrying out of building operations and other works for the performance of statutory powers or duties;
- (d) to enable a vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the lengths of road specified in the Schedules to this notice.

The Order will contain the usual parking concessions for disabled persons in accordance with the terms of the Orange Badge Scheme.

SCHEDULE I

(No Waiting at any time)

Lengths and sides of road subject to a
Prohibition of Waiting

1. *Bridgend Terrace* (B.4320), from its junction with Common Road in a south-westerly direction for a distance of 32 metres.
2. *Common Road*, from its junction with Westgate Hill in a south-easterly direction for a distance of 80 metres.
3. *The Parade*, from its junction with Westgate Hill in a south-easterly direction for a distance of 30 metres.
4. *Westgate Hill* (B.4320), from its junction with Common Road in an easterly direction to its junction with Northgate Street.
5. *Northgate Street* (A.4139), from its junction with Main Street in a northerly direction for a distance of 124 metres.
6. *Main Street* (A.4075)

(a) The north side:

(i) From its junction with Northgate Street in an easterly direction for a distance of 73 metres to the eastern side of the Bus Bay.

(ii) From its western junction with Orielson Terrace in an easterly direction to its eastern junction with Orielson Terrace.

(iii) From its western junction with East Back in an easterly direction to its eastern junction with East Back.

(iv) From its junction with Holyland Road in a westerly direction for a distance of 72 metres.

(b) The south side:

(i) From its junction with Northgate Street in an easterly direction for a distance of 11 metres to the eastern side of the Lion Hotel Archway.

(ii) From a point 63 metres east of its junction with Northgate Street at the eastern side of the Town Hall in an easterly direction for a distance of 208 metres.

(iii) From a point 70 metres east of its junction with New Way footpath in an easterly direction for a distance of 38 metres.

(iv) From its junction with Gooses Lane in a westerly direction for a distance of 37 metres.

7. *Orielson Terrace*, the south side, from its western to its eastern junction with Main Street.

8. *East Back*, the north side, from the eastern side of the Clinic in a westerly direction for a distance of 70 metres.

The south side, from a point 21 metres west of the north-western corner of Hamilton House in a westerly direction for a distance of 13 metres.

9. *Station Road* (A.4139), the north side from its junction with Holyland Road in an easterly direction for a distance of 126 metres.

The south side from its junction with Holyland Road in an easterly direction for a distance of 110 metres to the Bus Bay.

10. *Holyland Road* (A.4075), the north-west side, from its junction with East End Square in a north-easterly direction for a distance of 177 metres.

The south-east side from its junction with Station Road in a north-easterly direction for a distance of 155 metres.

11. *East End Square* (A.4075), the west side, from its junction with Main Street to its junction with Gooses Lane.

The south side:

(i) From its junction with Gooses Lane (kerbline) in a south-easterly direction for a distance of 2 metres.

(ii) From a point 12 metres south-east of its junction with Gooses Lane (kerbline) in a south-easterly direction to Well Hill.

The east side, from its junction with Station Road in a southerly direction to Well Hill.

12. *Well Hill* (B.4319), from its junction with East End Square in a general southerly direction to a point 46 metres south of its junction with Lower Lamphey Road.
