## NOTICE OF PUBLIC PATH ORDER

## TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210

*The County of Hereford and Worcester (Footpath No. 38,  
Stourport-on-Severn) Public Path Diversion Order 1975*

Notice is hereby given, that the above-named Order (hereinafter referred to as "the Order") made on the 12th day of December 1975 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the County Council of Hereford and Worcester as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running from a point approximately 33 yards south-east of Lickhill Lodge Farm and running in an easterly direction for approximately 83 yards to terminate at a point near its junction with Elmfield Walk, to a line commencing at the said point approximately 33 yards south-east of Lickhill Lodge Farm and running in a south-easterly direction for approximately 80 yards to terminate at a point where it connects with the tarmacadam footway extending in a north-easterly direction to Elmfield Walk.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Wyre District Council Offices, Civic Centre, Stourport-on-Severn between the hours of 9.30 a.m.-12.30 p.m. and 2 p.m.-4.30 p.m. on Mondays to Fridays.

Any representation or objection with respect to the Order may be sent in writing to the County Secretary and Solicitor, Shirehall, Worcester, not later than 19th January 1976 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn, the County Council of Hereford and Worcester may instead of submitting the Order to the Secretary of State for the Environment for confirmation themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

*The Leominster District Council (Almeley) Public Path  
Diversion Order, 1975*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 15th December 1975, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Leominster District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way being part of footpath No. A.M.7 on the definitive map commencing at its junction with the Class III road leading from Almeley to Holme Marsh in the County of Hereford and Worcester and running therefrom in a westerly direction for a distance of 370 feet or thereabouts to a new line commencing 60 feet or thereabouts north of the existing junction of the said footpath with the said Class III road and ending at the western end of the length of the said footpath proposed to be diverted.

A copy of the Order and the map contained in it has been deposited at the offices of the Leominster District Council, M.E.B. Buildings, West Street, Leominster and may be inspected free of charge at those offices between the hours of 8.30 a.m. and 4.30 p.m. on normal working days.

Any representation or objection with respect to the Order may be sent in writing to the Secretary and Solicitor, Leominster District Council not later than the 19th January 1976, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Leominster District Council may, instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objec-

## NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

## TOWN AND COUNTRY PLANNING ACT 1971—SECTION 210

*The District of Thurrock (Footpath No. 144—Tilbury)  
Public Path Diversion Order 1975*

Notice is hereby given that on the 8th December 1975 the Thurrock Borough Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert that part of footpath No. 144 which runs from a point marked 'A' on the map hereinafter referred to immediately to the north of the railway line near Brunel Close, Tilbury, in a generally south-easterly direction for a distance of approximately 200 feet to a point marked 'B' on the map, and thereafter south westwards for a distance of 300 feet, to a point marked 'C' on the map thereon shown by a bold black line, onto a new line starting from the aforementioned point marked 'A' and running in a southerly direction for a distance of approximately 230 feet to a point marked 'D' on the map and therein shown by a broken black line.

This Order becomes operative as from the 8th December 1975 but if any person is aggrieved by the Order and desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under Schedule 6 of the Town and Country Planning Act 1971
