### WATER ACTS, 1945 AND 1948

NORTHUMBRIAN WATER AUTHORITY  
SALMON AND FRESHWATER FISHERIES ACT 1975  
WATER ACT 1973  
*Fishery Byelaws*

Notice is hereby given that the Northumbrian Water Authority intend to apply to the Minister of Agriculture, Fisheries and Food, not less than one month after the date of publication of this notice for confirmation of Byelaws made by the Authority, the effect of which is as follows:

(a) To permit the use of certain baits and lures on the

Rivers Blyth and Wansbeck before 1st June in any year.

(b) To allow night fishing by means of natural or artificial fly mounted on a single hook within the Northern Area between 21st March and 25th October.

(c) To extend the weekly close time in the Northern Area so as to commence at 6 p.m. on a Friday evening.

(d) To prohibit Drift Netting (not 'T' Nets) for salmon or migratory trout within an area of the sea bounded on the north by a line drawn due west to the high water mark on the shore from a position Coquet Lighthouse bearing 355°—distance 3 miles 3.4 cables (as now indicated by Boulmer Stile Buoy), on the south by a line drawn due west to the high water mark on the

shore from a position Coquet Lighthouse bearing 160°—distance 1 mile 5.6 cables (as now indicated by Bondicarr Buoy) and on the east by a line drawn between these two positions.

Note: The existing Coquet Playground established by a Byelaw made by the former Northumbrian River Authority and confirmed by the Minister of Agriculture, Fisheries and Food on 14th March 1968 will remain in operation.

- (e) To prohibit netting by any means of salmon or migratory trout within an area of the sea bounded on the north by a line one mile in length drawn due east from Marconi Point Cullercoats, on the south by a line one mile in length drawn due east from Souter Point and on the east by a line joining the eastern extremities of the northern and southern boundary lines.

Note: The sea contained within a line drawn between Cleadon Hill Water Tower and South Pier Lighthouse, South Shields is excluded from the operation of this Byelaw and the Authority will permit some netting within that area regulated by means of permits to be issued to salmon net licensees by the Authority.

- (f) To provide for the marking and numbering of licensed salmon nets and boats.

During the period of one month from the date of publication of this notice a printed copy of the said Byelaws will be deposited at the office of the Authority (Northumbria House, Regent Centre, Gosforth, Newcastle-upon-Tyne NE3 3PX) and will be open to public inspection without charge on any week day other than Saturday during normal office hours. During the same period, printed copies of the Byelaws will be supplied on demand free of charge to any person appearing to the Authority to be interested. Any objection to the confirmation of the Byelaws should be made in writing and addressed to the Secretary, Ministry of Agriculture, Fisheries and Food, Fisheries Division, Branch 1B, Great Westminster House, Horseferry Road, London SW1P 2AE not later than 30th January 1976. ### TORFAEN BOROUGH COUNCIL

*Torfaen Borough Council (Henllys Way/Jule Road/Ton Road/Fairwater Way/Windsor Road) (Prohibition of Waiting) Order 1975*

to Saturday, on part of the road specified in Schedule 10 to this notice;

- (k) to prohibit the waiting of vehicles for a longer period than one hour in any period of three hours, 9.15 a.m. to 4.15 p.m., Monday to Saturday, on part of the road specified in Schedule 10 to this notice;
- (l) to prohibit the waiting of vehicles at any time and the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 p.m. and between the hours of 4.15 p.m. and 6.15 p.m., Monday to Saturday, on parts of the roads specified in Schedule 11 to this notice;
- (m) to prohibit the waiting of vehicles at any time and the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 a.m. Monday to Saturday, on part of the road specified in Schedule 12 to this notice;

## SUFFOLK COUNTY COUNCIL

*Suffolk County Council (Parish of Woodbridge) (Quay Street) (Prohibition of Waiting) Order 1975*

Notice is hereby given that on 18th December 1975 Suffolk County Council made an Order under Section 1 of the Road Traffic Regulation Act 1967 as amended, the effect of which is to prohibit the waiting of vehicles on the south-west side of Quay Street, Woodbridge from a point approximately 43.9 metres south-east of its junction with Cumberland Street in a south-easterly direction for a distance of approximately 18.3 metres.

## PORTSMOUTH CITY COUNCIL

*The Portsmouth (Palmerston Road Experimental Precinct) Order 1975*

Notice is hereby given that the Portsmouth City Council as agents for the Hampshire County Council and with the approval of the Secretary of State for the Environment on 19th December 1975 made an Order under Section 9 of the Road Traffic Regulations Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974.

(Exceptions will permit (1) emergency vehicles; (2) vehicles used in connection with road maintenance and public utility works; (3) mechanical road cleansing vehicles.)

(b) Stanley Street will be closed at its western end at its junction with Palmerston Road.

The proposals in this Order will enable an Experimental Precinct with buses only to be introduced.
