Road in Hitchin-

Hollow Lane on the northern side:

(i) From a point approximately 8 metres south of the Garrison Court for a distance of 17 metres south the line of the southern flank wall of Numbers 12A-18 Garrison Court for a distance of 17 metres in an easterly direction to a point approximately 28 metres east of the line of the eastern flank wall of Numbers 7-11 Garrison Court.

(ii) From a point approximately 7 metres east of the line of the eastern flank wall of Numbers 7-11 Garrison Court for a distance of 35 metres in a westerly direction to a point 1 metre west of the line of the western flank wall of Numbers 1-6 Garrison Court.
