The Lancashire County Council (Worston Road, Chatburn, Ribble Valley Borough) (Weight Restriction) Order, 197

Notice is hereby given that the Lancashire County Council propose to make the above Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968 and Schedule 19 of the Local Government Act, 1972 and Schedule 6 of the Road Traffic Act, 1974, the effect of which will be to prohibit any goods vehicle, the unladen weight of which exceeds 3 tons from proceeding in Worston Road, Chatburn from its junction with Clitheroe Road to its junction with the Whalley-Clitheroe By-Pass A.59.

The Order will contain exemptions to allow:

- (a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road;
- (b) for the purposes of agriculture in connection with the land adjacent to that length of road; and
- (c) for the use of vehicles in connection with any building operation, demolition or the maintenance of essential services.

WEST LANCASHIRE DISTRICT COUNCIL

West Lancashire District Council (Road South of Gillibrands Road, Skelmersdale) (Prohibition of Waiting) Order 1976.

Notice is hereby given that the District Council of West Lancashire (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Lancashire, in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act, 1974 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with section 84C (1) of the Act of 1967 propose to make an Order the effect of which will be:

To prohibit the waiting of vehicles on both sides and along the whole length of road leading from Gillibrands Road to John Dale Factory, Skelmersdale, a distance of 85 metres.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as is necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road, or the services therein or if the vehicle is a Disabled Person's Vehicle.

The draft Order, together with a relevant map and a statement of the Council's reasons for proposing to make the Order may be inspected at the Council Offices, Derby Street, Ormskirk, during normal office hours.

LEICESTERSHIRE COUNTY COUNCIL

The Leicestershire County Council (Various Roads, Mountsorrel) (One-Way System and Weight Restriction) Order, 1976.

Notice is hereby given that the Leicestershire County Council has made the above-named Order under the Road Traffic Regulation Act, 1967, the effect of which is to:

- (a) Prohibit any vehicle, the unladen weight of which exceeds 3 tons from proceeding along Watling Street, Mountsorrel and that length of unnamed road in the parish of Mountsorrel connecting Bond Lane with Rothley Road which extends from its junction with Crown Lane to its junction with Rothley Road;
- (b) Prohibit any vehicle from proceeding in:

 - (ii) That length of the aforementioned unnamed road which extends from its junction with Crown Lane to a point 47 yards north of its junction with Rothley Road, other than in a direction north-west to south-east.
