

(d) All the streets in the larger pedestrian precinct will be subject to no waiting at any time with the usual exemptions for delivery vehicles to wait for 30 minutes.

#### WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL

*The West Yorkshire Metropolitan County Council (Wakefield) (Traffic Regulation) (No. 31) Order 1975*
