(d) to impose a one-way system on each lane of the dual carriageway of Allerton Road.

The Order will contain exemptions for any wedding, funeral, emergency services vehicles and certain vehicles when used in pursuance of statutory powers or duties.

There will be an exemption for vehicles to wait for loading and unloading goods for up to 30 minutes, and disabled persons vehicles to wait for up to 2 hours, except in both cases in the lengths of Allerton Road, Pearson Lane and Rhodesway, during the periods when there is a ban on loading or unloading goods.

#### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

#### TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

*The County of Cambridgeshire and Isle of Ely (Footpath*  
*No. 12, Sawston) Public Path Diversion Order 1973*

Notice is hereby given that on the 22nd March 1976, the Cambridgeshire County Council confirmed the above Order. The effect of the Order, as confirmed, is to divert that part of Public Footpath No. 12 at Sawston, which runs from Church Lane to Babraham Road, being that part which commences at a point approximately 397 yards north-east of High Street and runs in a north-easterly direction for a distance of approximately 153 yards to a line commencing at a point approximately 397 yards north-east of High Street and running in a north-easterly direction for a distance of approximately 173 yards along a new estate road, thence in a north-westerly direction for a distance of approximately 25 yards to join the existing path.

A copy of the Order and the map contained in it has been deposited at the office of the undersigned and at the office of the Secretary, South Cambridgeshire District Council, Great Eastern House, Tenison Road, Cambridge, and may be inspected free of charge during normal office hours.

This Order becomes operative as from the date on which the County Council certify that a replacement right of way has been constructed to their reasonable satisfaction but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or any regulation made thereunder has not been complied within in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act 1971, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.
