The Trunk Road (St. Asaph, Clwyd) (One-Way Traffic) Order 1976

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle to proceed in a direction other than from east to west in the layby of the southern carriageway of the Chester—Bangor Trunk Road (A55) which extends from a point 53 yards west of its junction with Cwrtir Lane to a point 378 yards west of that junction.

The Trunk Road (St. Asaph, Clwyd) (Prohibition of Right-Hand Turn) Order 1976

Notice is hereby given that the Secretary of State proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle proceeding in an east-west direction in the layby at the side of the southern carriageway of the Chester—Bangor trunk road (A55) which extends from a point 53 yards west of its junction with Cwrtir Lane to a point 378 yards west of that junction, to make a right-hand turn into the main carriageway of the trunk road.
