This Court doth order that the name of the above named Nita Homes (Essex) Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Nita Homes (Essex) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioners the said Nita Homes (Essex) Limited and Albert Thomas Webb do pay to the Registrar of Companies his costs of the said petition such costs to be taxed on the Common Fund basis.
