#### HONOURS AND AWARDS

The QUEEN has been pleased to award The Queen's Police Medal for Gallantry to the late Constable Stephen Andrew Tibble of the Metropolitan Police in recognition of his gallantry in the following circumstances:

On 26th February 1975 a police officer engaged on plain clothes observation duty saw a man acting sus-piciously. He stopped him for questioning. While he was being questioned the suspect suddenly ran off and the officer gave chase, at the same time calling for assistance over his radio. As the suspect was pursued he was seen by a witness to take what appeared to be a gun out of his pocket. Two other plain clothes officers joined in the chase. At the same time Constable Tibble, who was off duty in plain clothes, gave chase on his motorcycle. He overtook the suspect, got off the motorcycle and faced the man attempting to arrest him. As Constable Tibble approached, the man shot him three times at a range of about six feet. Constable Tibble fell to the ground mortally wounded.

#### CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

To: Mr. L. A. JAMESON, P.O. Box 2796, Riyadh, Saudi Arabia.

Dated 17th June 1976

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely Yellow Gold Sovereign dated 1915 (Counterfeit) carried with you at London Heathrow Airport on 22nd December 1975 have been seized as liable to forfeiture upon the grounds that the said goods were imported contrary to the prohibition for the time being in force with respect these wades are the said goods. in force with respect thereto under section 42 of the Customs Consolidation Act 1876.

Whereby and by force of section 44 (b) of the Customs and Excise Act 1952 the said goods are liable to forfeiture. If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
