 WAGES COUNCIL (GREAT BRITAIN)

The Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Great Britain) hereby gives notice of proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Linen and Cotton Handkerchief etc.) Order 1975 (Order HL (83)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Linen and Cotton Handkerchief, etc.) (Holidays) Order 1975 (Order HL (84)); and (3) the revocation of Order HL (83) and Order HL (84).

The Wages Council intends that the revised provisions shall operate from 7th June 1976.
