

In the Manchester County Court. No. 10 of 1976

In the Matter of BACCOMATICS (DOMESTIC) LIMITED and in the Matter of the Companies Act 1948.

Notice is hereby given that by an order made on Friday the 28th day of May 1976 upon the petition of the above named Baccomatics (Domestic) Limited (hereinafter called the company) and of Ivan MacIntyre of 15 Raglan Road Sale Manchester a member of the company on the 22nd April 1976 preferred unto this Court

This Court doth order that the name of the above named Baccomatics (Domestic) Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Baccomatics (Domestic) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*

And it is ordered that the petitioners the said Baccomatics (Domestic) Limited and Ivan MacIntyre do jointly and severally pay to the Registrar of Companies his costs of the said petition such costs to be on the High Court Scale and to be taxed on the Common Fund basis, if not agreed.
