MEMORANDUM

REGULAR ARMY RESERVE OF OFFICERS

All officers of the Regular Army who attained the age limit of their rank and Corps on a date during the period 1st Apr. 1976 to 30th Jun. 1976, will cease to belong to the Regular Army Reserve of Officers on that date unless retained under Article 274 of the Pay Warrant 1964.

All Officers who:

(a) were members of the Territorial and Army Volunteer Reserve, the Army Emergency Reserve of Officers, the Territorial Army or the Territorial Army Reserve of Officers, and

(b) who transferred to the Regular Army Reserve of Officers, and

(c) who attained the age limit of their rank and Corps on a date during the period 1st Apr. 1976 to 30th Jun. 1976,

will cease to belong to the Regular Army Reserve of Officers on that date.
