

At the Court at Buckingham Palace the 2nd day of July 1976.

Present,

The QUEEN'S Most Excellent Majesty in Council

Whereas the Secretary of State for the Environment, after giving to the Incumbent and Churchwardens of the Parish of Stoney Stanton in the County of Leicestershire, ten days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act 1853 as amended by subsequent enactments, made a Representation to Her Majesty in Council that burials should be discontinued forthwith and entirely in St. Michael's Churchyard and Churchyard extension, in the said Parish, shown hatched on the plan annexed hereto.

Provided that—

(a) In any earthen grave now existing in the said Churchyard extension only, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

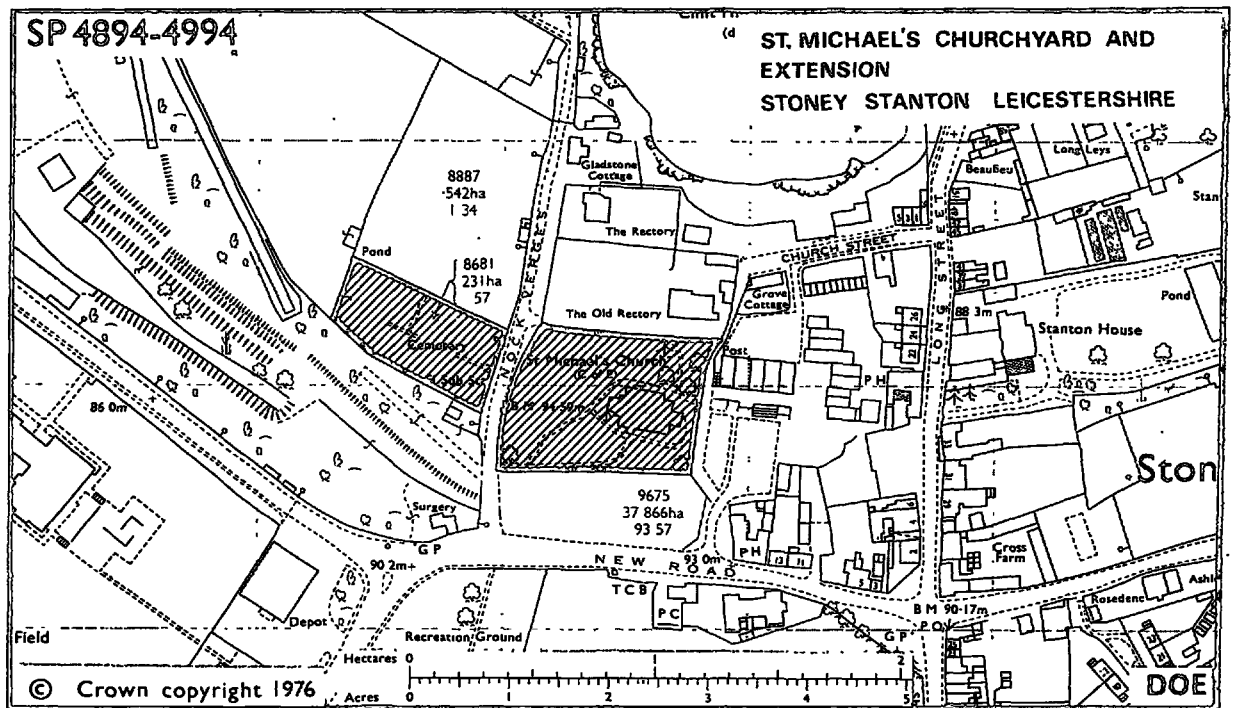
(b) In both the said Churchyard, and the said Churchyard extension in any grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 25th day of August next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 25th day of August.

The QUEEN has been graciously pleased to give and grant unto the Institute of Measurement and Control which has been reconstituted by Her Majesty's Royal Charter bearing date the 20th May 1975 Her Majesty's Royal Licence and Authority that they may bear and use in their corporate capacity on Seals or otherwise according to the Laws of Arms certain Arms, Crest and a Badge which were granted and assigned to the previous Institute of Measurement and Control by Letters Patent under the hands and Seals of Garter and Norroy and Ulster Kings of Arms bearing date the twentieth day of September 1968, the said Armorial Ensigns to be first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.

The QUEEN has been graciously pleased to give and grant unto the Lambeth, Southwark and Lewisham Area Health Authority (Teaching) Her Majesty's Royal Licence and Authority that they may bear and use, on Seals or otherwise according to the Laws of Arms, for the use of St. Thomas' Hospital, certain Arms, Crest and Supporters which were granted and assigned to St. Thomas' Hospital by Letters Patent under the hands and seals of Garter, Clarenceux and Norroy and Ulster Kings of Arms bearing date the 14th February 1950, the said Arms, Crest and Supporters to be first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.
