CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

To: DAVID NIMOCO, P.O. Box 1633, Accra, Ghana.

Date 15th July 1976.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely:

BMW 320 Motor car Registration No. MHM 848P

detained by an Officer of Customs on 28th February 1976 at London Airport, have been seized as liable to forfeiture upon the grounds that the Commissioners permitted David Nimoco of P.O. Box 1633, Accra, Ghana to acquire the aforementioned motor car as a new motor vehicle from a manufacturer without payment of tax for subsequent export on the condition that unless the said Commissioners of Customs and Excise otherwise allowed, the said David Nimoco would export it from the United Kingdom on his departure from the United Kingdom and this condition was not complied with.

Whereby and by force of section 12 (8) (b) of the Finance Act 1972 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this
