Northern Ireland Land Act, 1925

GUARANTEED 4½ PER CENT. BONDS

Notice to Bondholders of Numbers of the Bonds drawn for Payment on the 1st November, 1976

The Lords Commissioners of Her Majesty's Treasury hereby give notice that in accordance with the provisions of the Northern Ireland Land Act, 1925 (15 and 16 Geo. V., c. 34) and of the Northern Ireland Land (Finance) Rules, 1926, made thereunder, the within-mentioned Bonds amounting to £143,360, say One hundred and forty-three thousand three hundred and sixty pounds, were this day drawn for payment.

The Bonds will be paid off at par on or after the 1st November, 1976, at the Bank of England, London, unless registered in the Books of the Bank of Ireland, Belfast, in which case the Bonds will be redeemed at the Bank of Ireland, Belfast. Interest on the Bonds will cease from 1st November, 1976.

N.B.—Registered Bonds, accompanied by a request signed by all the Registered Holders for transmission of the Warrant for the Redemption money, must be presented at the Chief Accountant's Office, Bank of England, Threadneedle Street, London, EC2R 8AH, unless registered in the Books of the Bank of Ireland, Belfast, in which case the Bonds must be presented at the Transfer Office, Bank of Ireland, 54, Donegal Place, Belfast, BT1 5BX.

Bearer Bonds issued on or after 27th July, 1964 must be presented for payment by an Authorised Depository at the Loans Office, 1 & 2, Bank Buildings, Princes Street, London, EC2R 8EU, and should be lodged for examination three clear days before payment is required. Authorised Depositories are listed in the Bank of England's Notice EC 1 and include most banks, stockbrokers and practising solicitors in the United Kingdom, the Channel Islands or the Isle of Man.
