TOWN AND COUNTRY PLANNING ACT 1971

Any person aggrieved by any or all of the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to any or all of the Orders, may, within 6 weeks of the 17th September 1976, apply to the High Court for the suspension or quashing of any or all of the Orders or of any provision contained therein.

TOWN AND COUNTRY PLANNING ACT 1971

TOWN AND COUNTRY PLANNING ACT 1971
