**CLEAN AIR ACT, 1956**

*The Dartford District Council (Area No. 16)  
Smoke Control Order, 1976*

Notice is hereby given that the Dartford District Council (hereinafter referred to as "the Council") in exercise of the powers conferred on them by section 11 of the above-mentioned Act on the 1st November 1976, made an Order entitled The Dartford District Council (Area No. 16) Smoke Control Order, 1976, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemption provided by the Order and by virtue of section 11 (4) of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st September 1977, or before a later date determined by the Secretary of State for the Environment.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Council Offices, High Street, Dartford, at all reasonable times during the period of 6 weeks from the 11th November 1976.
