## NORTH WARWICKSHIRE BOROUGH COUNCIL

## CLEAN AIR ACT 1956

*The North Warwickshire Borough Council (No. 3) Smoke Control Order, 1976*

Notice is hereby given that the North Warwickshire Borough Council in exercise of the powers conferred on them by section 11 of the above-mentioned Act, on the 20th October 1976, made an Order entitled the North Warwickshire Borough Council (No. 3) Smoke Control Order, 1976, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke, and other carbonised fuels, gas and electricity.

If confirmed, the Order will come into operation on the 1st October 1977, or on a later date to be determined by the Secretary of State for the Environment.

Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the Chief Executive, Council Offices, Long Street, Atherstone, and the Environmental Officer, The Council House, Colehill, Birmingham, at all reasonable times during the period of 6 weeks from the 12th November 1976.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Department of the Environment, 2 Marsham Street, London S.W.1, object to the confirmation of the Order.

## SCHEDULE

The area of 357 acres or thereabouts and contained within the following boundaries within the Parish of Atherstone.

From the parish boundary at the western end of Long Street, Atherstone, along Long Street and Witherley Road, Atherstone in an easterly direction to the boundary with the Parish of Mancetter at Witherley Road, then generally in a south-westerly direction along the boundaries between the Parishes of Atherstone and Mancetter, and Atherstone and Bentley, then in a north-easterly direction along the boundary between the Parishes of Atherstone and Merevale, to the westerly point of Long Street, Atherstone.
