Exceptions are included in the Order to permit waiting

i) picking up and setting down passengers;

ii) loading and unloading goods; (iii) the exercise of Statutory Powers and Duties, including the maintenance of roads and the supply of gas, water and electricity;

(iv) the removal of furniture; (v) funeral services, and

(vi) disabled person's vehicles displaying the relevant disabled persons' badge.
