#### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 15th November 1976 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

- 1. Uniting the benefices of Stanton Saint Quentin with Grittleton and Leigh Delamere; Hullavington and Norton, in the diocese of Bristol.
- Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant Church of St. Mary, Barton Bendish, a former Chapel of ease in the parish of Barton Bendish, in the diocese of Ely.
- 3. Appropriating the redundant church of St. Cuthbert, Over Denton, a former chapel of ease in the parish of Gilsland, in the diocese of Carlisle, to use as a library and writing-room and empowering the said Commissioners to sell the said building for such use.
- 4. Uniting the benefices and parishes of Holy Trinity, Richmond, and Christ Church, Richmond, in the diocese of Southwark.
- 5. Uniting the benefices and parishes of Hadzor with Oddingley and Tibberton with Bredicot in the diocese of Worcester.
- 6. Appropriating part of the churchyard of the parish church of the parish of Saint James, New Bury, in the diocese of Manchester, for any ecclesiastical purpose affecting the parish or any part thereof.
- 7.—(1) Dissolving the benefices of Newbold-on-Stour with Halford; and Tredington; (2) creating a new benefice of Halford; (3) creating a new benefice of Tredington and Darlingscott with Newbold-on-Stour; (4) uniting the benefices of Preston-on-Stour with Whitchurch; and Atherstone; (5) others the street of the property of the proper (5) altering the name of the benefice of Ilmington with Stretton-on-Fosse; (6) establishing a group ministry for the benefices at (3), (4) and (5) above; and (7) altering the names of the parishes of Tredington and Atherstone, in the diocese of Coventry.
- 8. Vesting part of the churchyard of the parish church of the parish of Chigwell Row, in the diocese of Chelmsford, in the Chelmsford Diocesan Board of Finance for disposal.
- 9. Uniting the benefices of Brightling and Dallington, in the diocese of Chichester.
- 10. Transferring part of the parish of Stibbington, in the diocese of Ely, to the parish of Thornhaugh with Wansford, in the diocese of Peterborough.
- 11. Uniting the benefices and parishes of Christ Church, Blackburn; and Saint Matthew, Higher Audley, Blackburn, in the diocese of Blackburn.

- 12. Uniting the parishes of Offord D'Arcy and Offord Cluny in the diocese of Ely, and declaring redundant the parish church of the parish of Offord D'Arcy.
- 13. Uniting the benefices and parishes of Sherborne Saint John; and Monk Sherborne with Pamber, and altering the areas of the parishes of Monk Sherborne with Pamber; and Bramley, in the diocese of Winchester.
- 14. Establishing a team ministry for the area of the benefice of Saint John, Buckhurst Hill, in the diocese of Chelmsford, and transferring part of the parish of Saint Mary the Virgin, Loughton, to the parish of Saint John, Buckhurst Hill.
- 15. Uniting the beneficies of Heather and Ibstock, in the diocese of Leicester.
- 16. Uniting the benefices of Odiham with South Warnborough; and Long Sutton, in the diocese of Winchester.
- 17. Declaring redundant the churches of St. Michael and All Angels; and St. Saviour, being parish churches of the parish of Poplar, in the diocese of London.
