TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under Section 212 of the Town and Country Planning Act 1971 for extinguishing any rights which persons may have to use vehicles on those lengths of road specified in the Schedule to this Notice.

The Order contains provisions for permitting:

- (a) the use of the highway specified in Schedule 1 sub-paragraph (t) by the vehicles specified in Schedule 2; and
- (b) the use of highways specified in Schedule 1 sub-paragraphs (b), (c) and (d) by the vehicles specified in Schedule 3.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office (Y Swyddfa Gymreig), Transport and Highways Group, Government Buildings, Ty-Glas Road, Llanishen, Cardiff CF4 5PL (quoting the reference number WR15/71/13) and may be inspected at all reasonable hours at the offices of the Cardiff City Council, City Hall, Cardiff.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may within six weeks of 29th November 1976, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway to which the Order relates may claim compensation from the South Glamorgan County Council in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.—Dated 10th November 1976.

### SCHEDULE 1

The Highways are at Cardiff in the County of South Glamorgan. They are shown edged black on the deposited plan and are:

- a. Part of that length of highway known as Frederick Street which extends from a point 74 yards south of its junction with Queen Street, for a distance of 5 yards.
- b. Part of the southern side of that length of highway known as Cross Street which extends from its junction with Hill's Terrace, in an easterly direction for a width of 2 yards, and a distance of 13 yards.
- c. That length of highway known as Plymouth Street which extends from a point 23 yards south of its junction with Queen Street, in a southerly direction for a distance of 52 yards.
- d. Part of that length of highway known as Hill's Terrace which extends from its junction with Cross Street, in a westerly direction, for a width of 5 yards and a distance of 5 yards.

or other apparatus for the supply of gas, water, electricity or of any telegraphic line as defined in the Telegraph Act 1878 under, in, on, over or across the highway or any land adjacent to the highway.

- e. where the vehicle is a disabled person's vehicle which displays a disabled person's badge issued by a local authority in accordance with the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or a badge having effect under those Regulations as if it were a disabled person's badge between the hours of 6 p.m. and 11 a.m. on any day.

1. Where the vehicle is a vehicle of any description and is using the highway:

- i for police, ambulance or fire brigade purposes;

##### *Proposed Traffic Control—Hanley Bus Station*

Residents' cars, dual purpose vehicles, light goods vehicles or motorcycles, will be distinguished by the display of an annual permit which must be conspicuously display on the vehicle when parking on a residents' parking space within the restricted periods quoted above. Any vehicle parking in these residents' spaces not displaying a permit at these times will be committing an offence. Permits will be issued at any time upon request to a bonafide resident living in any of the streets within the controlled area free of charge and will be valid for one calendar year. Permits will be renewed on application annually. The issue of a residents' parking permit to a resident will permit the resident to park his car at any residents' parking space within the whole area. As explained above the resident will not require the permit to park outside the prescribed hours.

Residents' permits will indicate the area and year for which they are valid and will also show the registration number of the vehicle for which they are issued and will not be transferable to other vehicles. Whenever a resident changes his vehicle, a new permit will be issued in exchange for any existing permit.

Residents' parking spaces and all other parking spaces will be clearly marked on the roads with white lines and all vehicles parked in any parking place will have to park entirely within a parking place.

Exceptions will be permitted for a vehicle to wait at any time whether or not at a parking space, subject to any other separate restrictions, if it is:

- (a) picking up or setting down passengers;
- (b) waiting for the purpose of loading or unloading goods;
- (c) a vehicle being used for fire brigade, ambulance or police purposes;
- (d) waiting only for an obstruction to traffic to be removed;
- (e) in the service of or employed by the Post Office;
- (f) waiting in connection with any funeral, building operation, roadworks, work undertaken by Statutory Undertakers, or furniture removal.

The 2 hour limited waiting period applying at parking places other than those reserved for residents during the daytime will not apply to invalid carriages or vehicles displaying disabled drivers or disabled persons badges.
