## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 209 and 211 of the Above Act to authorise the stopping-up of lengths of Willow Tree Lane, Hayes, in the London Borough of Hillingdon, in order as to part to enable residential and ancillary development to be carried out jointly by the Greater London Council, The Hillingdon London Borough Council and the Ealing London Borough Council in accordance with planning permission granted under Part III of that Act; and in relation to the remainder, in the interests of the safety of users of and in order to facilitate the movement of traffic on the Willow Tree Lane distributor Link Road, which is a highway to be constructed in accordance with planning permission granted under Part III of that Act.

During 28 days from the 10th February 1977, copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Civic Centre, Uxbridge, Middlesex and also at the Yeading Library, Yeading Lane, Hayes, Middlesex, and may be obtained free of charge from the Secretary of State (quoting LH 38/5018/8/01) at the address stated below.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State (ref: LH 38/5018/8/01), St. Christopher House, Southwark Street, London, SE1 0TE, object to the making of the Order.

If an objection is made to the Secretary of State within the statutory objection period and it not withdrawn a local inquiry will be held at the Civic Centre, Uxbridge, Middlesex by J. Fleming, Esquire, O.B.E., F.R.I.C.S., F.I.H.M., M.B.I.M., on Thursday, 31st March 1977, commencing at 10.30 a.m.

This notice supersedes that published by the Secretary of State for the Environment on 1st July 1976, and also that published on the same date under section 210 of the above Act by Hillingdon London Borough Council. Any objections made in response to either of those notices will be considered as still standing unless the Secretary of State is advised otherwise by the objectors.
