THE GREATER MANCHESTER COUNTY COUNCIL

The Greater Manchester County Council (Eccles Old Road, Weaste Lane, Claremont Road and Rivington Road, Salford) (Prohibition of Waiting) (County) Order 1976.

Notice is hereby given that on 24th February 1977, the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit waiting at all times and to prohibit loading/unloading between 7.30 a.m. and 9.30 a.m. on Mondays to Saturdays and between 4 p.m. and 6.30 p.m. on Mondays to Fridays on:

Eccles Old Road, from Woodside Drive to a point 30 metres east of Claremont Road.

Weaste Lane, from Eccles Old Road for 75 metres in a southerly direction.

Claremont Road, from Eccles Old Road for 45 metres in a northerly direction.

Rivington Road, from Eccles Old Road for 15 metres in a northerly direction.

The Order contains exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading, (except when prohibited), the removal of furniture, funerals, building operations or work on or under the lengths of road. Disabled persons' vehicles bearing a disabled person's badge, and a parking disc, will be allowed to wait for periods up to 2 hours when a loading/unloading ban is not in operation.

A copy of the Order which comes into operation on 25th April 1977, and a map showing the roads to which it relates, may be inspected between the hours of 9 a.m. and 4.30 p.m. on Mondays to Fridays at:
