

Second Part (No Waiting Monday-Saturday 8 a.m. to 6 p.m.)

Tilford, north-east side, from a point 40 metres south-east of the junction with Alfred Road south-eastwards to a point 31 metres south-east of Menin Way.

South-west side

(a) from a point 20 metres north-westwards of the junction with Morley Road south-eastwards for a distance of 47 metres ;

(b) from a point 30 metres north-westwards of the junction with Great Austins south-eastwards for a distance of 71 metres.
