

The amount which an Authority borrows within its annual quota as determined by the said Commissioners will bear interest at the appropriate rate in the quota set of rates. Where Authorities borrow further sums these will attract interest at the appropriate rate in the Non-Quota set of rates, unless the said Commissioners agree that they should be offset against the following year's quota.

WAGES COUNCILS ACT 1959

NOTICE OF INTENTION TO MAKE A VARIATION ORDER TO EXCLUDE FROM THE SCOPE OF THE LICENSED NON-RESIDENTIAL ESTABLISHMENT WAGES COUNCIL LICENSED HOUSE MANAGERS AND THEIR SPOUSES AND CERTAIN OTHER CATEGORIES OF WORKERS

The Secretary of State for Employment in accordance with Schedule 1 to the Wages Councils Act 1959, as amended by the Employment Protection Act 1975, hereby gives notice that he intends, pursuant to his powers under section 4 (2) of the 1959 Act, to make a Variation Order to exclude the following categories of worker from the scope of the Licensed Non-Residential Establishment Wages Council:

- (1) Licensed house managers and their spouses; and
- (2) Workers who are employed as club secretaries, doormen, entertainers, greenkeepers, gardeners, grounds-men or skittle-alley attendants in licensed non-residential establishments (for whom minimum remuneration has not been set by the Council).

Objections to the draft Order must be sent to the Secretary of State at the above address not later than 20th May 1977. Every objection must be in writing and must state:
