The Order makes provision for the introduction (if so

required by the Council) of automatic tickets issuing machines and a parking charge of £5 for the failure to display such a ticket.

The Order provides for regulations governing the use of parking places at Margaret Street, Exmouth which shall be available to reserved annual season tickets holders only.

The Order may be seen at the Council Offices, Knowle, Sidmouth or the Council Offices, Exmouth on ordinary working days from Monday to Friday inclusive each week during normal working hours.

Season tickets will not be available for the Eastern Town (Ham) lorry park. The Mill Street car park is for use by holders of Reserved Car Park Space tickets at £25 per annum. Roxburgh car park will be only available for use by Season ticket holders.

The Order makes provision for the introduction (if so required by the Council) of automatic tickets issuing machines, and a parking charge of £5 for the failure to display such a ticket.
