UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the University of Oxford on the 10th March 1977, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The following notice is in substitution for that which appeared on page 4502 of the London Gazette dated 1st April 1977:

14. (1) Creating a new parish of Hempstead within the area of the benefice of Great Sampford with Hempstead; (2) uniting the benefices of Great Sampford with Hempstead; and Little Sampford; (3) transferring the new parish of Hempstead to the benefice of Radwinter; and (4) altering the names of the benefice of Radwinter and the parish of Great Sampford with Hempstead, in the diocese of Chelmsford.
