#### SCHEDULE

##### Route of the Motorway

(Being the route described in Schedule 1 to the Llangyfelach to North of Fforest Special Road and Connecting Roads Scheme 1972 (S.I. 1972/1797).

A route about 13.5 kilometres in length starting at a point on the East of Llansamlet to Llangyfelach Special Road about 280 metres east of its junction with Llangyfelach Roundabout at Llangyfelach in the County of West Glamorgan and proceeding in a general westerly direction and then in a northerly direction and ending at the roundabout on the new combined trunk road at Pont Abraham, north of Fforest in the County of Dyfed.

##### Routes of the connecting roads

(Being the routes described in Schedule 2 to the Llangyfelach to North of Fforest Special Road and Connecting Roads Scheme 1972 (S.I. 1972/1797).

1. A route to connect the Llangyfelach roundabout with the eastbound carriageway of the Motorway at Llangyfelach.

2. Four routes to connect the eastbound and westbound carriageways of the Motorway with the Swansea—Manchester Trunk Road at Penllergaer.

3. Four routes to connect the eastbound and westbound carriageways of the Motorway with Pontardulais Road at Hendy.

##### Town and Country Planning Act 1971 and Highways Act 1971

#### SCHEDULE 1

(All distances are approximate)

The lengths of highway to be stopped up are at Pontypridd in the Borough of Taff-Ely in the County of Mid Glamorgan are:

1. That length of Morgan Street which extends from its junction with Bridge Street in a general northerly direction for a distance of 27 yards.
2. That length of highway formerly known as Bridge Street which extends from the western side of its junction with the length of road described in Part 1 above in a general north-westerly direction for a distance of 15 yards.

The length of the private means of access to be stopped up is at Pontypridd in the Borough of Taff-Ely in the

County of Mid Glamorgan and is that length of the private means of access on the southern side of the premises known as No. 18 Morgan Street which extends from the highway boundary of Morgan Street for a distance of 28 yards.
