The Lord Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Accountant's Office (Bank Buildings) at the Bank of England on Friday, the 27th May 1977 at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of \$450,000,000 of £450,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They

will be dated at the option of the tendered on any business day from Monday the 30th May 1977 to Friday the 3rd June 1977 inclusive and will be due 91 days after date.

(being a multiple of one new halfpenny) which will be given for the amount applied for Separate Tenders must be lodged for Bills of different dates.
