PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 11th May 1977 by Order in Council to confirm the following Schemes made by the Church Commissioners

- 1. Providing for the Redundant Churches Fund to be responsible for the care and maintenance of the redundant part of the parish church of the parish of Adderley, in the diocese of Lichfield.
- 2.
