

to Cefn On Halt at its northern point to Cherry Orchard Road at its southern point;

- (d) to move the improvement of the combined Footpath No. 33 (Lisvane PH) and private means of access to Ty-yn-y-Berllan Farm, Lisvane, provided for in the 1975 Order for about 10 metres northwards and to extend the stopping up of this footpath and private means of access by about 18 metres northwards; and
- (e) to realign the position of the combined new Footpath No. 33 (Lisvane PH) and private means of access to Ty-yn-y-Berllan Farm provided for in the 1975 Order.

Copies of the Side Roads Orders and of the relevant plans have been deposited at the Welsh Office, Cathays Park, Cardiff, and at the offices of South Glamorgan County Council, County Headquarters, Newport Road, Cardiff, and the Newport Borough Council, Civic Centre, Newport, Gwent, where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by any of the Orders or either of them and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959 or the Highways Act 1971 or on the ground that any requirement of either those Acts, or of regulations made thereunder, has not been complied with in relation to any of the Orders, may within six weeks from 3rd June 1977, apply to the High Court for the suspension or quashing of any of the Orders or of any provision contained therein.

The Sides Roads No. 2 Order as made embodies part only of the proposals contained in the Order published in draft by the Secretary of State on 10th May 1976, under the title "The M4 Motorway (Castleton to Coryton Section) and Connecting Roads Scheme (Side Roads) (No. 2) Order 1977. The Secretary of State is deferring consideration of the remaining part of those proposals.
