TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of an irregularly shaped area of highway at the junction of Fenwick Avenue and Wenlock Road, South Shields, Tyne and Wear, to
