NOTICE OF PUBLIC FOOTPATH ORDER

South Cambridgeshire District Council (Barrington No. 4 and Haslingfield No. 16) Public Path Diversion Order 1977.

Notice is hereby given that the above named Order, made on 3rd June 1977, is about to be submitted to the Secretary of State for the Department of the Environment for confirmation, or to be confirmed, as an unopposed Order, by the South Cambridgeshire District Council.

The effect of the Order, if confirmed without modification, will be to divert part of Public Footpath No. 4 at Barrington and part of Public Footpath No. 16 at Haslingfield leading from Barrington to Harston, being that part which commences at a point approximately 680 yards north-east of Glebe Road, Barrington and runs in an easterly and north-easterly direction then in a south-easterly direction along the Barrington/Haslingfield Parish Boundary for a total distance of approximately 850 yards, to a line commencing at approximately 680 yards north-east of Glebe Road, Barrington and running in an easterly and south-easterly direction then in a general northerly direction on the western side of the soak ditch adjoining the River Cam or Rhee to meet the existing path for a total distance of approximately 1,070 yards.

A copy of the Order and the map contained in it may be inspected free of charge at the Council's offices, Great Eastern House, Tenison Road, Cambridge during normal office hours or at the residence of the Clerk to Barrington Parish Council, 10 Bendyshe Way, Barrington at all reasonable times.

Any representation or objection with respect to the Order may be sent in writing to the Secretary of the Council, South Cambridgeshire District Council, Great Eastern House, Tenison Road, Cambridge, before 20th July 1977 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the South Cambridgeshire District Council may instead of submitting the Order to the Secretary of State for the Department of the Environment, themselves confirm the Order. If the Order is submitted to

the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

HIGHWAYS ACT, 1959

(Footpath No. 14, Withnell) Public Path Diversion Order 1977

Notice is hereby given that on 6th May, 1977, the Lancashire County Council confirmed the above-named Order.

The effect of this Order, as confirmed, is to divert that part of Footpath No. 14 in the Parish of Withnell, Chorley Borough:

From its junction with Footpath No. 12 Withnell at a point 14.5 metres (16 yards approximately) east of Bolton Road, in a general easterly direction for a distance of 472 metres (517 yards approximately) along the following lines:

From a point on Bolton Road A.675, 137 metres (150 yards approximately) in a south-south-easterly direction, thence in an easterly direction for 274 metres (300 yards approximately), and thence in a north-easterly direction for 229 metres (250 yards approximately) to rejoin the existing footpath. The new footpath is approximately 2 metres wide.

A copy of the Order as confirmed and map contained in it has been deposited at the offices of the Chief Executive, Chorley Borough Council, Town Hall, Chorley, and at my offices, and may be inspected free of charge during normal office hours.

This Order became operative on 21st May 1977, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act 1959 as amended or on the ground that any requirement of the Act as amended, or of any regulation made thereunder has not been complied with in relation to the Order they may, under paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 7 to the Act within 6 weeks from the 21st June 1977, make application to the High Court for the purpose.
